A compulsory clarification meeting with representatives of the Employer will be held at **14:00 on Tuesday, 07 December 2021 via Microsoft Teams.** Tenderers must register per e-mail at Mr Marc Jacobs with e-mail address mcjacobs@george.gov.za **before 10:00 on Monday, 06 December 2021** in order to receive an invite for the compulsory clarification meeting.

The site visit details will be finalized at the Microsoft Teams compulsory clarification meeting. If tenderers do not register for attendance before **10:00 on Monday, 06 December 2021** with Mr Marc Jacobs; tenderers will not be able to attend the compulsory clarification meeting, and will invalidate your tender.

Bidders should be represented at the compulsory clarification meeting and site inspection by **a technical employee from the prospective bidder** who is suitably qualified and experienced to comprehend the implications of the work involved.

The certificate of attendance will only be signed after the site inspection.

Tender criteria:

Bidders must be registered with the CIDB and it is estimated that Bidders should have a grading designation of **6CE** or as per the required minimum threshold.

Only Tenders scoring a minimum of 110 out of 150 points in stage 1 for experience gained in **CIVIL WORKS ASSOCIATED WITH REFURBISHMENT/UPGRADING OF WATER AND WASTEWATER TREATMENT WORKS OR THE CONSTRUCTION OF WATER RETAINING CONCRETE and MECHANICAL WORKS ASSOCIATED WITH THE SUPPLY AND INSTALLATION OF LAMELLAR PLATES AT WATER/WASTEWATER TREATMENT WORKS** will be considered further for evaluation in stage 2.
