George Municipality invites tenders for tender no: ENG 011/2022 for the upgrading of the Glenwood and Protea 66/11kV substations in George. The project is planned to be executed over the 2022/23 and 2023/24 financial years.

Only bidders who satisfy the eligibility criteria stated in the Standard Conditions of Bid (Clause C.2.1) are eligible to submit tenders.

It is estimated that tenderers should have a minimum CIDB contractor grading designation of **6EP** or higher.

Proven previous experience in 66/11kV substation related projects is required and is part of the eligibility criteria of this tender.

A stipulated minimum threshold for local production and content is applicable for the supply of electrical cable products (90%), steel substation structures and hardware (100%), steel products and components (100%), transformers Class 0 and associated equipment (90%), plastic pipes (100%) and industrial lead acid batteries (50%). Annexure MBD 6.2 must be fully completed by bidders.

All bids received shall be evaluated in terms of the George Municipality's Supply Chain Management Policy, read with the Preferential Procurement Regulations of 2017. It is estimated that the **80/20** preference points system will be applicable. Tenders will be evaluated in terms of price and preference.
