Tenders sal as volg ge-evalueer en toegeken word:

- Stage 1:** Administrative compliance and mandatory requirement;
- Stage 2:** Functionality evaluation – phase 1 (only tenders scoring a minimum of 40 out of 70 points in stage 2 will be further considered for evaluation in stage 3);
- Stage 3:** Functionality evaluation – phase 2: Site visit (only tenders scoring a minimum of 28 out of 35 points in stage 3 will be further considered for evaluation in stage 4);
- Stage 4:** Price and Preference (B-BBEE) - Tenders will be evaluated and adjudicated in terms of the Preferential Procurement Policy Framework Act (Act 5 of 2000) Regulations 2017 and the George Municipality's Supply Chain Management Policy, where 80 points will be scored for price and 20 points for BBEE status.

- Stadium 1:** Administratiewe voldoening en verpligte vereistes;
- Stadium 2:** Voorafbepaalde kriteria – fase 1 (slegs tenderaars wat 'n minimum van 40 uit 70 punte behaal in stadium 2, sal verder vir evaluering in stadium 3 oorweeg word);

- Stadium 4:** Prys en Voorkeur (B-BBEE) – Tenders sal ge-evalueer en toegeken word in terme van die Wet op die Raamwerk vir Voorkeurverkrygingsbeleid (Wet 5 van 2000) Regulasies 2017, asook George Munisipaliteit se Voorsieningskanaalbestuursbeleid, waar 80 punte ten opsigte van die prys en 20 punte ten opsigte van B-BBEE status toegeken sal word.
