DEPARTMENT OF TRANSPORT AND PUBLIC WORKS
DRAFT REGISTRATION AND LICENCE FEES FOR MOTOR VEHICLES
REGULATIONS, 2022

The Provincial Minister of Mobility in the Western Cape, in terms of section 7 of the Western Cape Provincial Road Traffic Administration Act, 2012 (Act 6 of 2012), intends to make the regulations set out in the Schedule.

SCHEDULE**Definitions**

1. In these regulations, any word or expression defined or used in the National Road Traffic Act, 1996 (Act 93 of 1996), or the regulations made under that Act, has the same meaning, unless the context indicates otherwise.

Registration and licence fees

2. The fees payable in respect of the registration and licensing of motor vehicles in the Province are as set out in the Annexure.

Repeal

3. The regulations published under Provincial Notice 7/2020 in *Provincial Gazette* 8201 dated 5 February 2020 are repealed.

Commencement

4. These regulations come into effect on 1 August 2022.
