TERMS OF REFERENCE

APPOINTMENT OF A TOWN PLANNING AND GIS MENTOR

ISDG INTERNSHIP TRAINING PROGRAM

Three (3) year contract

PREAMBLE:

- A. The Directorate: Human Settlements, Planning and Development (Department: Planning and Environment) wish to appoint a Service Provider to perform the all ISDG Mentoring functions as per the ISDG Framework of 2014 and as outlined in the “Road to Registration for Supervisors and Mentors on the ISDG Programme” handbook of 2017, as may be amended by National Treasury / SAICE from time-to-time.
- B. The mentoring functions rendered by the Service Provider must be undertaken by a person that:
- (a) holds a town planning qualification of NQF 7 (preferably from an academic university) and higher that is recognized by the South African Council for Planners (SACPLAN) – not holding such qualification will lead to automatic disqualification;
 - (b) is registered as a professional town planner with SACPLAN (registration certificate) and can demonstrate that he/she is in good standing with SACPLAN – bidders not holding such registration will **lead to automatic disqualification**;
 - (c) is an adequately experienced practicing or retired town planner / town planning consultant with demonstrated relevant experience in development management and spatial planning as indicated in the attached scoresheet;
 - (d) can demonstrate adequate experience in managing / mentoring town planning (and GIS) interns for purposes of professional registration with their professional body (SACPLAN / SAGC) as indicated in the attached scoresheet;
 - (e) is resident in the George area or immediate surrounding area;
 - (f) can demonstrate a clear understanding of the scope of work required to enable the town planning / GIS interns to register with their professional bodies with the period prescribed by the ISDG program;
 - (g) can demonstrate a clear understanding of the deliverables and outcomes sought from the Mentor in terms of the program (refer to Clause 3);
- C. The nominated registered professional town planner must be a co-signatory to the Service Level Agreement and accept and assume the responsibilities therein;

- D. The Service provider shall render the services to the Directorate on the terms and conditions as set out in a Service Level Agreement (**see draft agreement Annexure B**).

1. INTERPRETATION

- 1.1 Unless the context indicates a contrary intention, a word or expression which denotes:
- 1.1.1 any gender shall include the other genders;
 - 1.1.2 a natural person shall include juristic persons and vice versa; and
 - 1.1.3 the singular shall include the plural and vice versa.
- 1.2 The terms and conditions contained in the General Conditions of Contract (GCC), shall form part of the agreement between the Parties.
- 1.3 In the event of any inconsistency between the provisions of the Service Level Agreement and the terms and conditions contained in the GCC, or any annexure to the Service Level Agreement the provisions of the Service Level Agreement shall prevail over the terms and conditions contained in the GCC.
- 1.4 For the sake of clarity, any reference in the GCC to the term “Supplier” shall equate to the term “Service Provider” and any reference in the GCC to the term “Purchaser” shall equate to the term “Directorate”.
- 1.5 The following expressions bear the meanings assigned to them below and cognate expressions bear corresponding meanings: -
- 1.5.1 **“Agreement”** shall mean a Service Level Agreement, together with the bid documents, the GCC, and any other annexures hereto, and **“the Agreement”** shall have a corresponding meaning;
 - 1.5.2 **“Commencement Date”** means the date of appointment of the service provider, being 01 February 2023, notwithstanding the date of signature of the Agreement;
 - 1.5.3 **“Council”** means the municipal Council of George Municipality;
 - 1.5.4 **“Directorate”** means the Directorate: Human Settlements, Planning and Development of the George Municipality situated at the corner of York and Progress Street, George;
 - 1.5.5 **“ISDG Programme”** means the Infrastructure Skills Development Grant graduate internship programme in accordance with the Service Level Agreement entered into between the National Government of the Republic of South Africa represented by National Treasury and the George Municipality;
 - 1.5.6 **“Parties”** means the Directorate and the Service Provider;
 - 1.5.7 **“Service Provider”** means the company (with a representative person) or a person (individual), duly nominated and in service of the company, holding the requisite recognized professional Town

Planning degree and professional registration with the South African Council of Planners;

1.5.8 **“Residence”** means an office or residential premises located within George or not less than 30km from George;

1.5.9 **“Allowance”** means an allowance paid to the Service Provider for any travel related directly to the attending meetings related to the ISDG program outside George. No travel allowance is payable for travel within George area or for engaging with Interns and Supervisors of Interns in George area; (See clauses 6.7 and 6.8)

1.5.10 **“Termination Date”** means the date the appointment of the service provider ends, being 3 years from date of appointment or such other date as may be determined by agreement between the Parties;

1.6 Words and expressions defined in any clause shall, for the purpose of that clause, bear the meaning assigned to such words and expressions in that clause.

2. APPOINTMENT AND DURATION

2.1 The Directorate wish to appoint the Service Provider to provide the Services in accordance with the deliverables outlined in clause 3 below and on the terms and conditions as contained in this document.

2.2 The selection and evaluation of the Service Provider will be based on the credentials of the employee nominated by the Service Provider that will render the mentoring serve (i.e., the nominee and not that of the Service Provider.

2.3 The appointment under clause 2.1 shall be exclusive to the Mentor nominated by the Service Provider and the Service Provider shall accordingly not appoint any other party to provide the services to the Directorate, unless with the prior written approval of the Directorate and subject to such Mentor or subcontractor being bound by the terms and conditions of the Agreement.

2.4 Should the nominated Mentor leave the service of the Service Provider, the Service Provider shall immediately nominate a replacement Mentor to ensure an uninterrupted service to the Directorate. The Service Provider may not replace a Mentor without the prior written approval of the Directorate and subject to such Mentor being bound by the terms and conditions of the Agreement.

2.5 The Agreement shall come into effect on the Commencement Date and shall, unless otherwise provided for in the Agreement, remain in force until the completion of the Services to the satisfaction of the Directorate.

3. THE SERVICES

- 3.1 The Service Provider shall render the following services to the Directorate on the terms and conditions set out below, (hereinafter referred to as “the Services”):
 - 3.1.1 To perform all the ISDG Mentoring functions as per the ISDG Framework of 2014 and as outlined in the “Road to Registration for Supervisors and Mentors on the ISDG Programme” handbook of 2017, as may be amended by National Treasury / SAICE from time-to-time; and
 - 3.1.2 To perform all duties in relation to the mentoring function that may be allocated to him/her, when required, by the Directorate, subject to the conditions as the Council may prescribe.
 - 3.1.3 The Service Provider to note that the maximum number of interns at any time will not exceed **six (6) interns**.
- 3.2 The contents of all deliverables will, as a minimum, meet the requirements of the ISDG programme.
- 3.3 The Service Provider shall perform the Services as follows:
 - 3.3.1 The Service Provider will need to budget for a **minimum of 24 hours of Mentoring per month**, equitably distributed among the interns employed by the Directorate at any given time, including any meetings or engagements with the Interns’ supervisors, the ISDG coordinators and National Treasury/ SAICE;
 - 3.3.2 The Service Provider shall report to the Interns’ Supervisor as registered on the ISDG programme and the Senior Manager: Town Planning of the George Municipality;
 - 3.3.3 The Service Provider shall be required to work out and agree on a training schedule for each intern with the Supervisor. Should the intern be seconded to undertake experiential training with another company or state institution, the Service Provider shall work out and agree on a training schedule with the seconder’s Supervisor. The Service Provider shall provide a training progress report for each intern to the Directorate every month;
 - 3.3.4 The Service Provider shall meet with the Supervisor and/or designated supervisor to discuss all relevant matters relating to the training programme **at least once a month** and submit minutes of the meeting to the Directorate every month;
 - 3.3.5 The Service Provider shall maintain a detailed activity logbook that records all mentoring work undertaken and time allocated for the services rendered. The logbook must be submitted with a Portfolio of Evidence of the mentoring to and signed off by the Supervisor and/or designated supervisor (as the case may be) every month;

- 3.4 The Service Provider must co-ordinate all processes, appointments, meetings and engagements with the Interns, Supervisors, and Directorate.

4. REPORTING AND LEVELS OF SERVICE TO BE RENDERED BY THE SERVICE PROVIDER

- 4.1 The Service Provider shall provide a **monthly** progress report, along with the documents stated on 3.3.2 to 3.3.4 above by the **5th** working day of each month for the duration of the Agreement which shall contain the following information pertaining to the Services of the previous month:
- 4.1.1 A detailed summary of mentoring undertaken with each intern;
 - 4.1.2 A report on the status of the mentoring and progress on the intern's road to professional registration;
 - 4.1.3 The challenges faced;
 - 4.1.4 Any interventions required;
 - 4.1.5 Additional training courses, workshops, seminars and conferences etc interns can attend; and
 - 4.1.6 Budget requirements for such additional training.
- 4.2 The Directorate reserves the right to request additional information pertaining to any matters or issues raised in or issues omitted from a report as well as any other relevant information.
- 4.3 The Service Provider shall attend any further meeting at the request of the Directorate to discuss matters pertaining to the Agreement.
- 4.4 The Service Provider shall keep minutes of each meeting and shall make same available to the Directorate and annex them to the relevant monthly reports.

5. OBLIGATIONS OF THE SERVICE PROVIDER

- 5.1 The Services must be performed in a professional and impartial manner and the Service Provider shall at all times observe and abide by the SACPLAN Code of Conduct for Registered Persons.
- 5.2 The Service Provider shall:
- 5.2.1 exercise reasonable skill, care and diligence in performing the Services; and
 - 5.2.2 ensure that Services are performed in accordance with the deliverables and obligations as required by a Mentor of the ISDG programme.

6. PAYMENT / SERVICE FEE

- 6.1 The following shall apply:

- 6.1.1 The Directorate shall pay the Service Provider a set service fee, which is the rate stated by the service provider in the bid submitted / or a lower rate as agreed between the parties;
- 6.1.2 The Service Provider shall charge this fee at a **per hour rate (inclusive of VAT)**.
- 6.1.3 **No annual escalation** of service fee shall be applicable.
- 6.1.4 The Directorate will determine the maximum number of hours that the Service Provider may charge per month based on the rate stated in the bid submitted / agreed between the parties;
- 6.1.5 The available funding for each month will be fixed, hence the monthly amounts claimed may not exceed the budgeted monthly amount;
- 6.1.6 The Service Provider must submit all invoices and the monthly report (refer to 4.1 above) within 5 days of the end of the month;
- 6.1.7 The Service Provider will be paid within 30 (thirty) days of receipt of a detailed invoice together with the monthly report (refer to 4.1 above) provided that the services to which the invoice relates have been rendered to the satisfaction of the Directorate.
- 6.2 The following details must be reflected on invoices forwarded to the Directorate by the Service Provider:
 - 6.2.1 The total amount payable with reference to the activities and outputs referred to in clauses 3 and 4 above;
 - 6.2.2 VAT payable;
 - 6.2.3 The tender/contract number.
- 6.3 The Directorate will verify the correctness of the invoice and notify the Service Provider of any possible discrepancies within 10 (ten) days of receipt of the invoice. Provided that the invoice is correct, the amount due shall be payable within 30 (thirty) days from receipt of the invoice.
- 6.4 If the Directorate identifies any material discrepancies, the invoice will be referred back to the Service Provider, and the amount due will be payable within 30 (thirty) days from receipt of a corrected invoice.
- 6.5 No payment will be made in respect of Services that are incomplete and not in line with the requirements of the Agreement.
- 6.6 Payments by the Directorate to the Service Provider shall be made by electronic funds transfer into a bank account in South Africa, as nominated in writing by the Service Provider.
- 6.7 The Directorate shall not reimburse the Service Provider for any further disbursements, including, but not limited to parking, computer consumables, telephone calls, stationary, printing, travel, catering and accommodation costs that are incurred to render the Services.
- 6.8 Notwithstanding clause 6.7, the Service Provider may arrange with the Directorate for the reimbursement of travel and accommodation costs

relating to an intern that has been seconded outside of the George Municipal area or to attend an engagement / meeting scheduled through the ISDG program outside the George Municipal area. Such costs shall be reasonable and shall align with Council’s Travel and Accommodation policies.

7. INTELLECTUAL PROPERTY RIGHTS

The Service Provider shall have no claim or entitlement to any copyright or other intellectual property that arises out of the execution of the Agreement, ownership of which shall at all times vest in the Directorate. The Service Provider may not reproduce or use the copyright or any intellectual property of the unless it obtains the prior written permission of the Directorate.

8. INDEPENDENT CONTRACTOR

General Conditions of Contract

1. **Definitions:**
1. The following terms shall be interpreted as indicated:
 - 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 “Day” means calendar day.
 - 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order.
 - 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
 - 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13 “Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
 - 1.14 “GCC” means the General Conditions of Contract.
 - 1.15 “Goods” means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
 - 1.16 “Imported content” means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be

imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.

- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application:

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General:

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards:

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information inspection:

5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the provider in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.

5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the provider's performance under the contract if so required by the purchaser.

5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights:

6.1 The provider shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

6.2 When a supplier developed documentation / projects for the municipality or municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality or municipal entity.

7. Performance security:

7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or

- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing:

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents:

- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the supplier in accordance with the terms specified in the contract.

11. Insurance:

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

12. Transportation:

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

13. Incidental services:

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the provider for similar services.

14. Spare parts:

14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty:

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this

contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment:

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

17. Prices:

- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the provider in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders:

- 18.1 In cases where the estimated value of the envisaged changes in purchase does not exceed 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment:

- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts:

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under these contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the Supplier's Performance:

21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.

21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.

21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties:

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default:

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;

- (b) if the supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
 - (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction;
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Anti-Dumping and Counter-Vailing duties and rights:
 - 24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-

dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure:

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency:

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of disputes:

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
(b) the purchaser shall pay the supplier any monies due to the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of liability:

28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;

- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language:

- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law:

- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices:

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties:

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
- 32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of contracts:

- 33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts:

- 34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the

contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of restrictive practices:

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties are contemplated in section 59 of the Competition Act No 89 of 1998.
- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
