Tenders are hereby invited for the **UPGRADING OF CONVILLE WATER RETICULATION NETWORK.**

Only those tenderers who have in their employ management and supervisory staff satisfying the requirements of the scope of work and who have completed the relevant NQF levels 4 and 5.

Stage 1: Functionality
