In terms of a Council meeting held on 20 September 2023, notice is hereby given of the approval granted by Council in respect of the proposed sale of the vehicles subject to certain conditions, of which the salient terms are as described below:

The sale is required in terms of the negotiated agreement entered into between George Link (Pty) Ltd, the Municipality of George and Western Cape Provincial Government, via its Mobility Department in 2014 following a public participation process wherein public comment was requested. The above sale price was determined to be the "nominal value". "Nominal value" is required to be charged by the parties in terms of this agreement. The proposed sale will take place in terms of the requirements of the Municipal Asset Transfer Regulations. The sale is also aimed at meeting transformation and empowerment goals and actioning the plight of the poor in the George community.

Die verkoop word vereis ingevolge die onderhandelde ooreenkoms wat in 2014 tussen George Link (Edms) Bpk, die George-munisipaliteit en die Wes-Kaapse provinsiale regering, via sy Departement van Mobiliteit aangegaan is na 'n openbaredeelnamaproces waarin openbare kommentaar versoek is. Bogenoemde verkoopprijs is bepaal as die "nominale waarde". "Nominale waarde" moet ingevolge hierdie ooreenkoms deur die partye gehou word. Die voorgestelde verkoop sal plaasvind ingevolge die vereistes van die Munisipale Bate-oordragregulasies. Die verkoop is ook daarop gemik om transformasie- en bemagtigingsdoelwitte te bereik en die nood van die armes in die George-gemeenskap aan te spreek.
