## **PUBLIC PARTICIPATION PROCESS:**

## GWAING-, SCHAAPKOP- AND MEULEN RIVER INTERGRATED RIVER MANAGEMENT PLANS (RMPs) (INCLUSIVE OF MAINTENANCE MANAGEMENT PLANS (MMPs))

George Municipality (GM) appointed Zutari (Pty) Ltd to develop integrated River Management Plans (RMPs) for the following river systems:

- Gwaing River
- Schaapkop River
- Meulen River

<u>Project Proposal</u>: The George Municipality (GM) has taken a proactive step towards the sustainable management of its watercourses by aiming to develop separate integrated River Management Plans (RMPs) for the three key river systems listed above. An essential element of the RMPs is the inclusion of a Maintenance Management Plan (MMP), which acknowledges the importance of preserving functional infrastructure while ensuring the ecological health of the river systems is protected.

The overarching objectives of the RMPs are two-fold:

- 1. To facilitate efficient maintenance of existing infrastructure along the watercourses; and
- 2. To improve the ecological functioning of the watercourses and enhance ecosystem services benefits that the watercourses provide through targeted interventions.

Legal Framework: The RMPs (inclusive of MMPs) have been developed to seek authorisation for maintenance related activities in terms of the National Environment Management Act (NEMA, Act No. 107 of 1998, as amended). The project will additionally also seek General Authorisation (GA) in terms of the National Water Act (NWA, No. 36 of 1998), specifically GN R4167 of December 2023. The final RMPs (following conclusion of the public engagement process) will be submitted to the Western Cape Department of Environmental Affairs and Development Planning (DEA&DP) for decision-making.

<u>Available Information</u>: The Draft RMP for each river system is being made publicly available for a **30-day review and comment period** from **15 August 2025 to 15 September 2025**.
