- The workforce will have to wear personal protective clothing, i.e. overalls, safety boots, safety eyewear, hard hats, protective gloves and reflective vests.
- Site area must be demarcated to restrict access for individuals.
- Contractor will be responsible for the provision of required safety and access signage to all accesses to building site.
- Contractor will be held liable for any damages to municipal property, directly
  or indirectly, as a result of the construction process, delivery of materials or as
  a result of damages caused by any labour or sub-contractors employed by
  the contractor.
