GENERAL

FOR THE PERIOD 1 JULY 2026 TO 30 JUNE 2027

THE TARIFFS RECORDED IN THIS SCHEDULE BECOME EFFECTIVE ON 1 JULY 2026 FOR ALL ACCOUNTS RENDERED ON OR AFTER THIS DATE. ALL TARIFFS ARE SUBJECT TO VALUE ADDED TAX, UNLESS STATED OTHERWISE.

For the purposes of this tariff schedule the following shall mean:

“Act”

Local Government: Municipal Systems Act, 2000 (Act no. 32 of 2000) together with the Local Government: Municipal Finance Management (Act no. 56 of 2003);
Local Government: Municipal Property Rates Act, 2004 (Act no. 6 of 2004);
Local Government Municipal Property Rates Amended Act, 2014 (Act no. 29 of 2014);
Municipal Fiscal Powers and Functions Act, 2007 (Act no. 12 of 2007).

“Development Charges”

For purposes of these charges please refer to the approved Guidelines, as amended from time to time for the calculation of Development Charges;

“Consumer”

A person or persons or body corporate occupying or partially occupying premises independently of any other person or persons or body corporate, irrespective of whether electricity is used by such a consumer, used jointly with other consumers or used separately.

Annual Payment of Property rates

Applications to pay property rates on an annual basis can be submitted in writing to the George Municipality by the owner of the taxable property before 30 June of any financial year and stays in effect until further notice by the owner.

“Financial Year”

The “financial year” means a year ending on 30 June;

“Penalties”

Penalty charges calculated at the standard rate per annum, are payable as follows: -

a) Accounts payable monthly - accounts not fully paid after the date specified as “due date” on accounts. Normally the “due date” is the 15th day of the month which follows the month during which an account is rendered.

b) Accounts payable annually - accounts not fully paid after the date specified as “due date” on accounts. Normally the “due date” is 30 September of each year.

With regard to the determination of due dates:

Whenever any act, event or thing is required to be done in terms of Councils' Policies or performed or to take place on or before a certain day, at or before a certain time or during a certain period and such day, time or period falls, on or such period expires on a Saturday, Sunday or public holiday, such day, time or period shall be deemed to fall or expire on the succeeding day which is not a Saturday, Sunday or public

“Public Transport”

“Public Transport Services” means a scheduled public transport services for the carriage of passengers by road, for a fare as contemplated in this tariff list.

“Repeat offender”

Applies to an owner or developer that have been penalised in the past 5 years for a similar offence, whether said offence occurred on the same property as the application in question or on another property, developed by that same owner or developer, at the time of charging the penalty.

“Standard rate”

The standard rate in relation to interest means that interest, in respect of monies, rates and charges in arrears to Local Authorities will be raised at prime rate, as charged by the commercial banking industry of

1.2 Property Rates - Exemptions, reductions and rebates

Residential Properties: For all residential properties, the municipality will not levy a rate on the first R230 000 of the property's market value. The R230 000 is inclusive of the R15 000 statutory impermissible rate as per section 17(1)(h) of the Municipal Property Rates Act.

Rebates in respect of a category of owners of property are as follows:

1. Indigent owners:

All indigent owners, for rating purposes, will qualify in respect of their primary place of residence for the first R230 000 reduction, of the property's market value, plus for the rebates as stipulated under point 2 below.

2. Low-income owners:

Owners with a collective income of less than R16 500 but not more than R18 150 per month, for rating purposes, will qualify in respect of their primary place of residence for the following rebates:

Gross Monthly Household Income	% Rebate
If the total income as defined in the Municipality's Property Rates Policy is less than R198 000 per annum (R16 500 per month) - 10% increase in rebate	40% on property rates
If the total income as defined in the Municipality's Property Rates Policy is R198 000 or more per annum, but less than R217 800 per annum (R16 501 - R18 150 per month) - 10% increase in rebate	20% on property rates

3. Owners who are dependent on Pension or Social Grants for their livelihood, excluding customers who are already receiving indigent benefits may qualify for the following:

A rebate of 40%, up from 35%, of property rates will be applicable to Pensioners earning up to R429 000, up from R390 000 per annum, on the first two-million-four hundred- and seventy-five-thousand-rand valuation (R2 475 000) of the property (up from R2 250 000). This will apply to persons over the age of 65 years for their single primary residence.

4. Properties

To avoid fruitless and wasteful expenditure the municipality will not levy a rate on any private road or any other property where the market value of the property is equal to or less than R30 000 or such other amount as determined by Council during the budget process.

Full details of the Council resolution and rebates, reductions and exclusions specific to each category of owners of properties or owners of a specific category of properties as determined through criteria in the municipality's rates policy are available for inspection at the municipality's offices and on website (www.george.gov.za).
