**The following tenders were not considered for evaluation:**

1. **CDV Munval (Pty) Ltd** - Staff members (Municipal Valuer and Substitute Municipal Valuer) do not possess the required experience the tenderer is deemed non-responsive (R5,230,415.00);
2. **Uniqueco Properties (Pty) Ltd** - Staff members (Data Capturer /Administrative Assistants) do not meet the requirements, the company do not have the required experience in coastal areas and that an example of a General Valuation (GV) and Supplementary Valuation (SV) was not provided in the prescribed format, the tenderer is deemed non-responsive (R8,829,398.00);
3. **Penny Lindstrom Valuations** - The proposed staff members (Data capturers /Administrative Assistants) do not meet the requirements and the company indicated "no" to having the required experience in coastal areas, the tenderer is deemed non-responsive (R8,021,610.00).
4. **Eagilwe Property Consulting and Asset** - The company do not have the required experience in coastal areas and that an example of a General Valuation (GV) and Supplementary Valuation (SV) was not fully compliant in the prescribed format, the tenderer is deemed non-responsive (R8,943,940.00);
5. **Qhawekazi Global (Pty) Ltd** – The Administrative Assistants / Data Capturers, Field workers nominated do not meet the requirements, the tenderer is deemed **non-responsive** (R6,435,440.00);
6. **HCB Valuation and Services (Pty) Ltd**- the company submitted a Sworn Affidavit claiming a BBBEE Level 2 status, the Municipality subsequently requested supporting information. The information provided was not deemed sufficient to verify the BBBEE Status claimed. The company was therefore found non-responsive (R6,580,500.00).
