1. Uluvo lwam General Trading – failed to acknowledge receipt of all Addenda issued, which included critical notice regarding changes within the Bill of Quantities, as required under the responsiveness criteria (R31,803,327.05);
2. Mayenzeka Indiyabo JV – did not score the minimum threshold for functionality (R33,723,825.67);
3. Berlex Consortium's – offer was deemed non-responsive as they failed to submit the required financial offer, as stipulated in the tender documents (R0.00);
4. Ramashu Supply and services – bid was found non-responsive as they failed to submit the required financial offer, as stipulated in the tender documents (R0.00);
5. Malihlema Trading & Projects 928 (Pty) Ltd – did not score the minimum threshold for functionality (R39,443,357.80);
6. Exilite (Pty) Ltd – did not score the minimum threshold for functionality (R37,064,588.55);
7. Khamina Civils 1914 CC – did not score the minimum threshold for functionality (R217,589,930.25);
8. Baybreeze trading 390 CC – did not score the minimum threshold for functionality (R19,546,976.08);

10. All fired up Construction & Project – did not score the minimum threshold for functionality (R4,064,298.81);
11. Lulworth Building Services JV – did not score the minimum threshold for functionality (R8,790,991.00);
12. Eyethu Projects & Plant hire – did not score the minimum threshold for functionality (R12,443,204.13);
13. Keewave Trading 334 – offer was deemed non-responsive as they failed to submit the required financial offer and did not attend the compulsory information session as stipulated in the tender documents (R0.00);
14. Illolo Trading CC – offer was deemed non-responsive as they failed to submit the required financial offer, as stipulated in the tender documents and did not attend the compulsory information session as stipulated in the tender documents (R0.00);
15. Bajadi Investments & Projects 133 – failed to acknowledge receipt of all Addenda issued, which included critical notice regarding changes within the Bill of Quantities, as required under the responsiveness criteria (R40,433,499.80);
16. Ricokona Construction and Manufacture Supplies (Pty) Ltd / Amaqoqa Civils JV – submitted a fraudulent BBBEE Certificate confirmed by the Verification Agency.
17. Mvezo Thulandile JV did not attend the compulsory information session as stipulated in the tender documents (R38,808,401.17)
